To seek to maintain a high income, through investment in a spread of fixed interest securities denominated predominantly in euro.

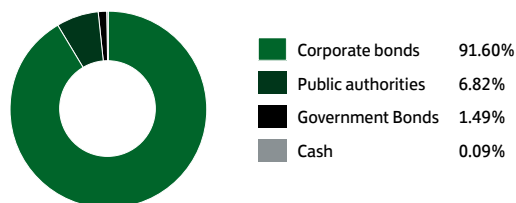

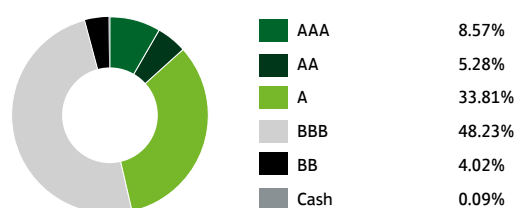
